The working group carried out monitoring activities on the internship programs scheduled at the Universities of Baghdad, Qadisiyah and Kufa (by Eleonora Mariani and Marco Valeri from the University of Bologna as persons in charge of monitoring) in January 2023. #### University of Baghdad (09/01-13/01/2023)

#### **3. Final recommendations**

The overall quality of the teaching units is in line with the standards. The working group would just indicate few minor recommendations to improve the teaching quality:

1. We recommend the internship offices to open more positions to involve a growing number of students. A positive outcome of this program represents is ideal for a future application in all the universities in Iraq.

2. We recommend the professor to constantly inform the students of the possibility to apply for an internship and how they represent a useful mean of personal and professional growth.

3. We recommend private companies to involve more students in the internship programs, as they represent an opportunity to train future qualified employees and for the economic growth of the region.

#### \*Institutional meetings

1. On 10/01, prof. Nicolò Marchetti met in Baghdad H.E. the Minister of Higher Education and Scientific Research in Baghdad, discussing about the activation of mandatory internship programs in Iraqi MA university courses and the creation of regular seminars addressed to professors and administrative staff at national level and based on the guidelines framed by the Bologna Process.

2. On 10/01, prof. Nicolò Marchetti met in Baghdad Barbara Egger, EU Head of Cooperation for Iraq, to discuss about the financial issues on staff costs for EU-financed projects and the solutions agreed with Bruxelles. In detail, they agreed on adopted a model adapted from past and ongoing employability projects in Iraq by the European Commission and not only related to Cultural Heritage.
