GENERAL INFORMATION

The application procedure is made by 2 main steps:

- 1. Studenti Online in order to upload all the required document.
- Forms Online in order to choose the Thematic Area and to order all the <u>doctoral positions</u> based on your preference within the chosen Thematc Area;



Applications submitted in any way other than the above will not be considered.




1. Login to <u>studenti.unibo.it</u> and click "**Register**" if you do not have an Unibo Account

Studenti Online is a space reserved for students of the Alma Mater Studiorum - University of Bologna, which allows you to conveniently carry out online procedures, from registration to graduation.

Time spent on compulsory national service or on the procedure required to obtain refugee status under the Geneva Convention will not be considered.

I DECLARE

O that I have not benefited from contracts as a research fellow or fixed-term assistant professor contracts pursuant to articles 22 and 24 of Law 240/2010 at the University of Bologna or at other Italian public, non-governmental or telematic universities, as well as the bodies referred to in paragraph 1 of article 22 of Law 240/2010 for a period which, added to the duration envisaged by the contract to which this call refers, exceeds a total of 12 years, including non-continuous contracts. Periods spent on maternity leave or leave for health reasons in accordance with the legislation in force do not count towards the duration of these relationships


- 1. Italian Public Universities: self-certification of the Second-cycle/Master's degree or degree under the previous system, dated and signed.
- 2. EU/Non-EU State Universities:
 - Master's Degree Certification;
 - Academic Transcript of records for the Master's degree including the full list of the passed exams and the related marks (in English).
- 3. Italian Private Universities: alternatively to the certificate, complete self-certification of all required data, or the Diploma Supplement.

In case of on condition application (candidates who are yet to obtain their Master's Degree): academic Transcript of records including the full list of the passed exams and the related marks (in English).
