CALL FOR PAPERS

II International Congress of Comparative and Constitutional Law "Cuba CON-PARA 2026"

Professors, researchers, students, and other professionals of Law and Political Science from all over the world are invited to the II International Congress of Comparative and Constitutional Law "Cuba CON-PARA", to be held in Havana, from February 3 to 6, 2026.

Cuba CON-PARA has been conceived as a unique space for knowledge interchange from a comparative perspective and on the most current concerns of Constitutional Law.

The Congress has been structured around seven working sessions that cover the most important areas of constitutional interest.

- **Session n. 1** Determining elements for updating the classifications of state forms.
- **Session n. 2** Cryptotypes and non-traditional formats in the definition of the legal phenomenon.
- **Session n. 3** Rethinking the welfare state in light of the non-compliance or regression of economic and social rights: which instruments and which strategies?
- **Session n. 4** Beyond legal personality: human, non-human, transhuman and posthuman.
- **Session n. 5** The legacy of Roman private law and European codes in the legal systems of Latin America, within the framework of the globalized economy.
- **Session n. 6** Actors in the construction of a just society: legislators and judges between cooperation and conflict.
- Session n. 7 (extraordinary) Celebration of the 50th anniversary of the Cuban Constitution of 1976.
