












GIORGIO SACERDOTI



Born March 2nd, 1943. Law Graduate cum laude, University of Milan (1965). Master of Comparative Law, Columbia Law School, New York (1967). Admitted to the Bar (Milan, 1969, and Supreme Court of Italy, 1978). Senior Professor since 1st November 2013. Emeritus since 2016. Formerly tenured professor of International Law and European Law (Jean Monnet Chair since 2004) at Bocconi University (1994-2013). Formerly professor at the Universities of Milan, Bergamo, Urbino and Bari. International fellow, Aspen Institute.

Prof. Sacerdoti is also visiting professor at the Institut des Hautes Etudes Internationales, University of Paris and in universities in various countries. Course holder at the Academy of International Law of The Hague (1994). Former Coordinator of the Bocconi PhD program in International Law and Economics. Member of the Board of editors of the Italian Yearbook of International law and of the Editorial Advisory Board of the J. of World Investiment & Trade. ICSID (World Bank) Roster of arbitrators.

Formerly vice-president of the OECD Working Group on Bribery in International Business Transactions (1995-2001). Member of the Appellate Body of the WTO 2001-2009 (Chairman 2006/2007). F. Braudel Senior Fellow at the European University Institute (2012). President of CDEC Foundation (Jewish contemporary documentation centre), Milan, since 2004. Member of the Italian Consultative Commission on Religious Freedom, (since 2000). Research areas in Public international law, Conflicts of law., uropean law, International trade, Foreign investment and dispute settlement, International contracts and commercial arbitration, Protection of religious freedom.














JAMES BACCHUS

James Bacchus is the Distinguished University Professor of Global Affairs and Director of the Center for Global Economic and Environmental Opportunity at the University of Central Florida. He was a founding judge and was twice the Chairman – the chief judge - of the highest court of world trade, the Appellate Body of the World Trade Organization in Geneva, Switzerland. He is a former Member of the Congress of the United States, from Florida, and also a former international trade negotiator for the United States.

Prof. Bacchus is a Global Fellow of the Centre for International Governance Innovation in Canada and an Adjunct Scholar of the Cato Institute in Washington, D.C. He is the Pao Yue – Kong Chair Professor at Zhejiang University in Hangzhou, China. He served on the High-Level Advisory Panel to the Conference of Parties of the United Nations Framework Convention on Climate Change, chairs the global Commission on Trade and Investment Policy of the International Chamber of Commerce, and chaired the global sustainability council of the World Economic Forum. For more than fourteen years, he chaired the global practice of the largest law firm in the United States and one of the largest in the world. Professor Bacchus is the author of the books Trade and Freedom, published by Cameron May in London in 2004, and The Willing World: Shaping and Sharing a Sustainable Global Prosperity, published by Cambridge University Press in 2018. The Financial Times named The Willing World one of the "Best Books of 2018." He is a frequent writer in leading publications and a frequent speaker on prominent platforms worldwide on numerous topics relating to international law and international political economy.

PETER VAN DEN **BOSSCHE**



Peter Van den Bossche is a former Member and Chair of the Appellate Body of the World Trade Organization (2009-2019), and is currently Director of Studies and Professor of International Economic Law at the World Trade Institute of the University of Bern, and President of the Society of International Economic Law (SIEL). Van den Bossche is also an honorary professor at Maastricht University and a visiting professor at the Bocconi University, Milan (2023), the Université de Genève (since 2018), LUISS Guido Carli University, Rome, Italy (since 2016), at the Universidad San Francisco de Quito, Ecuador (since 2016), and at the College of Europe, Bruges (since 2010).

He is member of the Advisory Board of the World Trade Review, Journal of International Economic Law, the Journal of World Investment and Trade and the Revista Latinoamericana de Derecho Comercial International. Since 2013, he is also member of the Advisory Board of the WTO Chairs Programme (WCP). Van den Bossche is on the roster of arbitrators for disputes under the EU-UK Trade and Cooperation Agreement (TCA), the EU-Canada Comprehensive Economic and Trade Agreement (CETA), and the EU-Andean Community Trade Agreement, on the panel of arbitrators of the Shenzhen Court of International Arbitration (SCIA) and the South China International Arbitration Center (Hong Kong) (SCIAHK), and on the EU list of candidates suitable for appointment as arbitrators and TSD experts. He holds an LL.M. from the University of Michigan, Ann Arbor (1986) and a PhD in law from the European University Institute, Florence (1990). Van den Bossche graduated magna cum laude from the Faculty of Law of the University of Antwerp (1982). He worked at the Court of Justice of the European Communities, Luxembourg, as référendaire of Advocate-General W. Van Gerven (1990-92) after which he joined the Faculty of Law of Maastricht University. From 1997 to 2001, Van den Bossche was Counsellor to the Appellate Body of the World Trade Organization, Geneva. In 2001, he served as Acting Director of the Appellate Body Secretariat after which he returned to Maastricht University as Professor of International Economic Law. From 2005 to 2009, Van den Bossche was Head of the Department of International and European Law of Maastricht University. In 2007, he founded the Institute for Globalisation and International Regulation (IGIR) at Maastricht University and served as its first Academic Director until 2009. Van den Bossche is the author (with Werner Zdouc) of The Law and Policy of the World Trade Organization, 5th edition (Cambridge University Press, 2022, and (with Denise Prévost) of Essentials of WTO Law, 2nd edition (Cambridge University Press, 2021). . 















WEIHUAN ZHOU



Dr Weihuan Zhou is Associate Professor and Co-Director of the Herbert Smith Freehills China International Business and Economic Law (CIBEL) Centre at the Faculty of Law and Justice, University of New South Wales Sydney. His research explores the most current and controversial issues in the field of international economic law, particularly the nexus between international trade law and China. He has published widely in this field.

Prof. Zhou's latest book, published by the Cambridge University Press, offers one of the first thorough and systemic analysis of China's ongoing reforms of state-owned enterprises and the ways to tackle China's state capitalism under the world trading system. His work has been cited widely, including in reports of the European Parliament, the Parliament of Australia, Australia's Productivity Commission, US Congressional Research Services and World Economic Forum. Dr Zhou is currently co-Secretary of the Society of International Economic Law (SIEL) and editorial board member of the Journal of International Trade Law and Policy.
