## SHORT CVS OF FACILITATORS AND SPEAKERS

**Guglielmo Apolloni** is a Designer and Social Entrepreneur. As Designer he's part of Somos Más, international agency harnessing collective intelligence for the benefit of social Ecosystems, and of Social Seed, italian agency specialised in designing innovation processes. As Social Proto-Entrepreneur he co-founded School Raising, the first Italian crowdfunding platform for school projects, and Mitosis, a "family feeling" co-working space in Berlin. In his work Guglielmo combines four words - #diffuse #creativity #design #thinking - to enable people to use own creativity in group to build solutions to their challenges, and be resilient for the next ones. Following a research made by Ashoka Italy in Feb 2015, Guglielmo is one of the first 12 more connected changemakers in Italy.

Lucia Balduzzi is Associate professor at the Department of Education Science, University of Bologna. Her recent studies and publications focuses on the analysis of education policies at national and international level and on the professional profile of practitioners working with children in conventional and experimental pre-school services. In particular, the research guidelines concern the innovations that are currently occurring in the early childhood education and care sector at pedagogical, cultural, didactic and organisational level. The analysis, at policy level, aims to investigate the relations between institutions, educational policy and models for the delivery of childcare services. A particular attention is drawn to the analysis of these mutual interactions as they affect the pedagogical identity of the services in terms of educational methods adopted by the different childcare centers. The methodologies used in empirical research refer to qualitative data collection and analysis methods, as well as action research methodologies for supporting ECEC staff professional development. In particular, her recent edited books focus on ECEC services and staff professionalism (Balduzzi & Manini, '*Professionalità e servizi per l'infanzia*', Carrocci, 2013) as well as on professionalization tools in early years educational contexts (Balduzzi & Pironi, '*L'osservazione al nido'*, Franco Angeli, 2017).

**Mária Baracsi** is Head of Unit of International Cooperation at IFKA Public Benefit Non Profit Ltd. for the Development of the Industry, focusing on (social) business development and international expansions, with responsibility for formulating and executing interregional and transnational co-operations. Ms. Baracsi has more than 10 years of management experience in industry, government and research institutions. Prior to her current role, she has been working for the European Commission (DG Research) as well as in research projects with the Microsoft Corporation, the Johns Hopkins University and Imperial College London. At present, Ms. Baracsi is the Coordinator of the INTERREG EUROPE project "SOCIAL SEEDS" to exploit the potentials of social enterprises through standardized European evaluation and development system. Moreover, she is leading the INTERREG DANUBE Programme project "SENSES" to create a transnational network of the social enterprise ecosystems that will jointly promote an innovative social enterprise model as well as social innovation for the sustainable economic development of the Danube region.

Graduating in economics, Ms. Baracsi has completed doctoral studies at the 'Enterprise Theory and Practice Ph.D. School' at the University of Miskolc (Hungary) and spent 9 months as visiting researcher at INSEAD Business School in France. Her dissertation is investigating the 'Game Theory in cluster excellence: the innovation management and technology-transfer perspectives'.

**Clemens Binder** works with aspiring social entrepreneurs in the Social Impact Lab Duisburg, a social startup incubator in the region North Rhine-Westphalia in Germany. His role is to ensure the necessary skills and qualifications of the founders and support them with training and expertise to realize their social enterprises. **Giulio Ecchia** is Professor of Economics, Department of Economics, University of Bologna and Professorial Lecturer of Economics, SAIS Europe, Bologna. His research interests include the economics of cooperative firms and social enterprises, corporate governance and stakeholder theory and the economics of regulation. He is member of the board of the Social Economy and Civil Society Integrated Research Team of the University of Bologna, a multidisciplinary research group of scholars working on themes such as social economy, social innovation, third sector and civil society. He is member of the scientific committee of the journal Impresa sociale, EURICSE, Trento, of the executive board and of the scientific committee of AICCON (Italian University network on Business Ethics and CSR) and of the scientific committee of AICCON (Italian Association for the Promotion of Cooperative and Non-profit Culture). He is currently coordinating the University of Bologna team in the H2020 project InnoSI (Innovative social investment: strengthening communities in Europe).

**Franco Farinelli** is Professor of Geography at the Department of Philosophy and Communication Studies at the University of Bologna and serves as Head of Department of Philosophy and Communication Studies. He has been visiting professor at many Universities, among which the University of Geneva, the University of Paris Pantheon Sorbonne, the University of California (Berkeley), the Nordic Institute for Urban and Regional Planning, Stockholm and the University of California Los Angeles (UCLA). He is currently President of the Italian Geographical Association. His wide research interests include, among others, the analysis of the nature of territorial networks in the modern times and the study of models of interpretation of globalization. He is interested in the urban and sociocultural challenges and dynamics that operate and influence social changing processes, and social innovations inside city regions.
