INTERNAL (IFE)

evaluation carried out for each technical workpackage

EXTERNAL (EFE)

-quality of the trainings;
-impact on the internationalization of HEIs involved

SUMMATIVE EVALUATION

INTERNAL (ISE)

a conclusive evaluation of the overall project
a **final report** to be used for future exploitation

EXTERNAL (ESE)

a final evaluation carried out by an external evaluator
final report to be disseminated among project partners, Asian Universities and external stakeholders

REPORTS THE RESULTS OF EACH QUALITY ASSESSMENT TO THE GENERAL CONSORTIUM ASSEMBLY

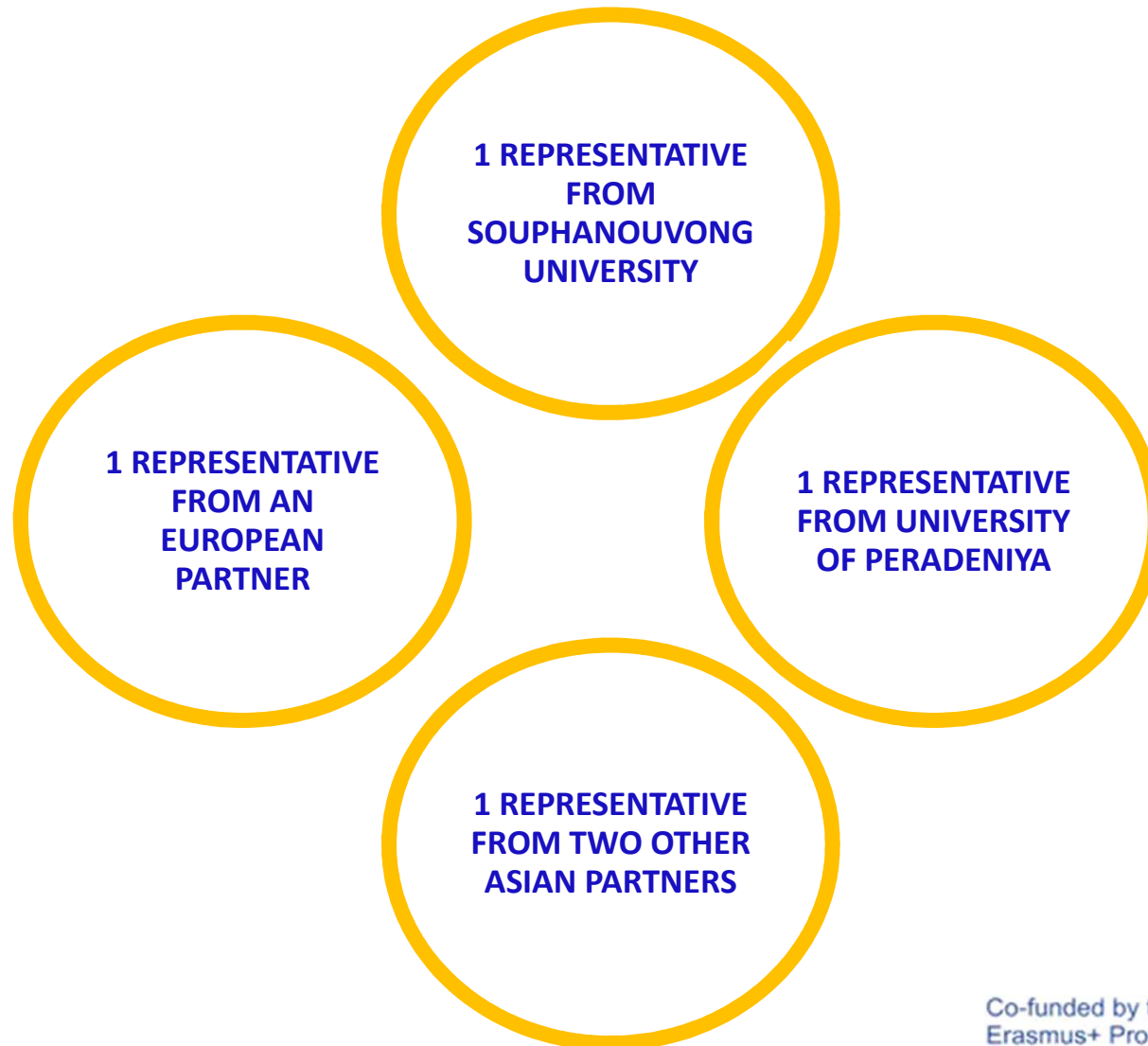
PROPOSES CORRECTION ACTIONS IN CASE OF WEAKNESSES OR FLAWS
